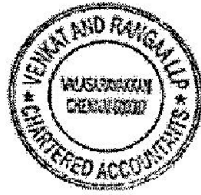
Review Report to the Board of Directors of

1. 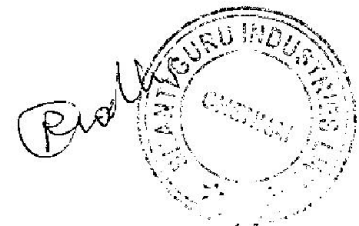

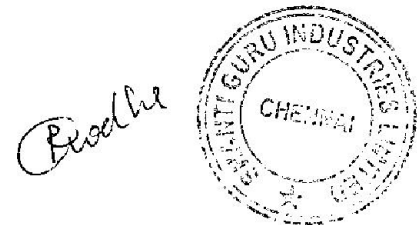
